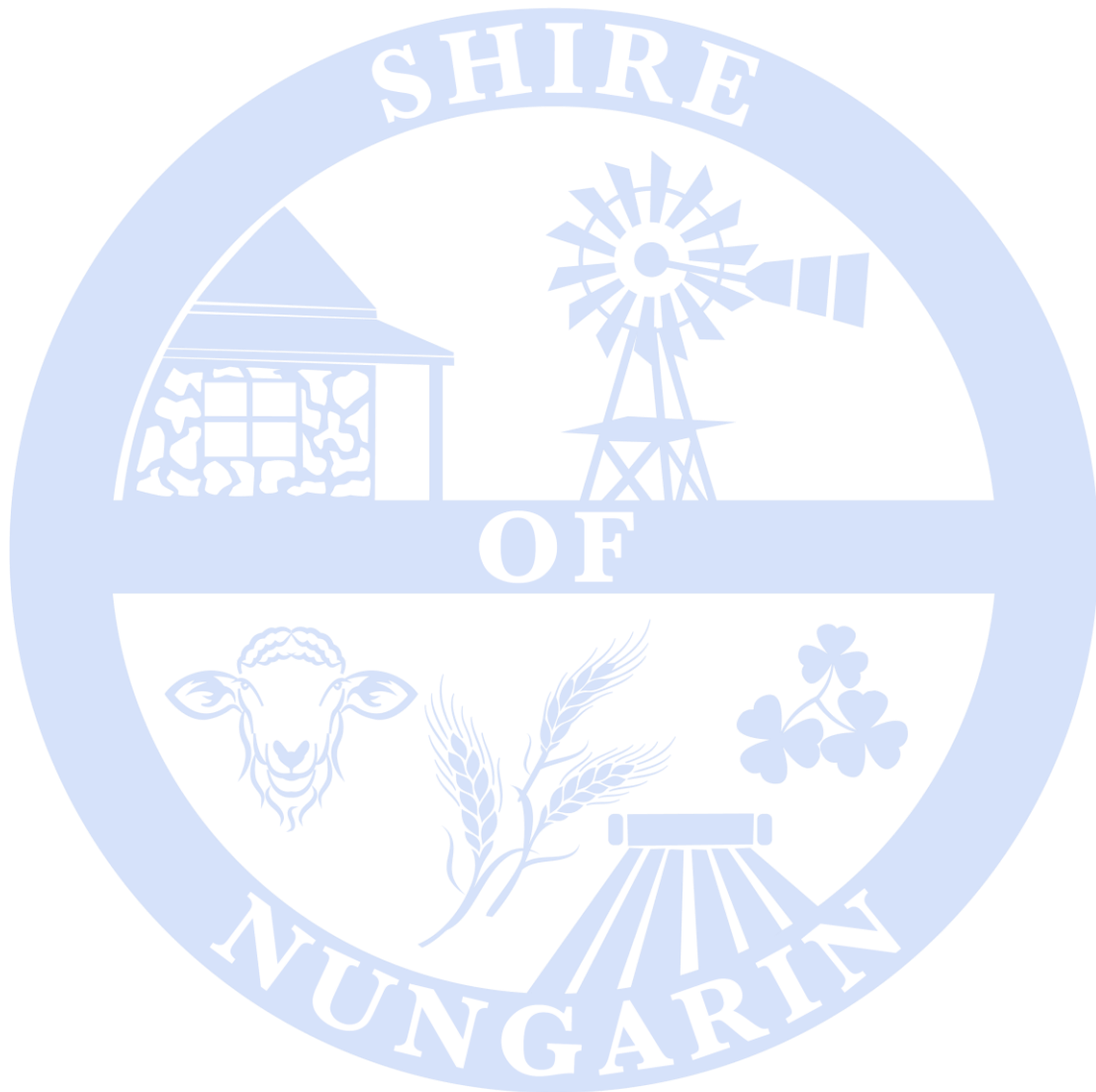

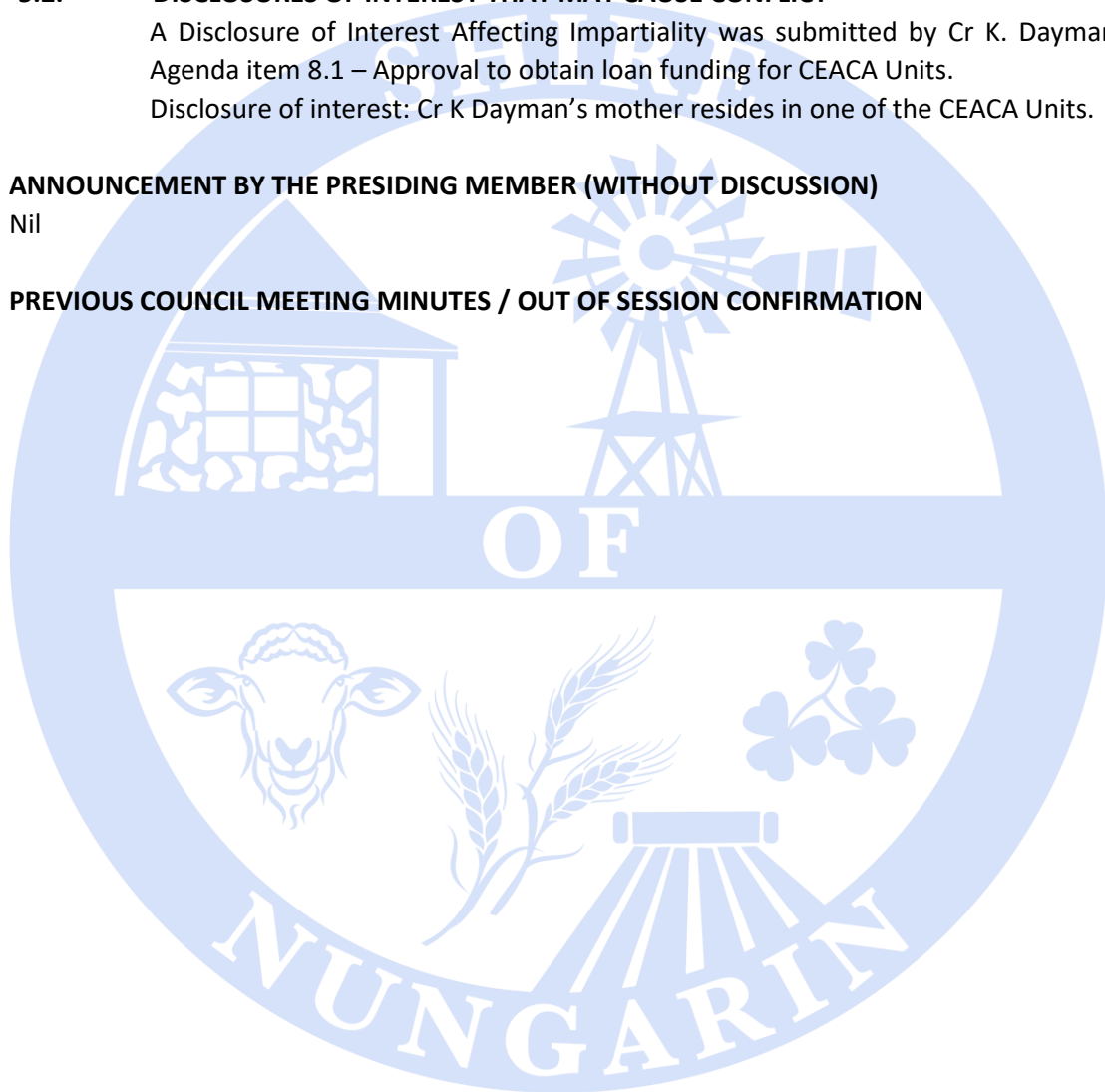

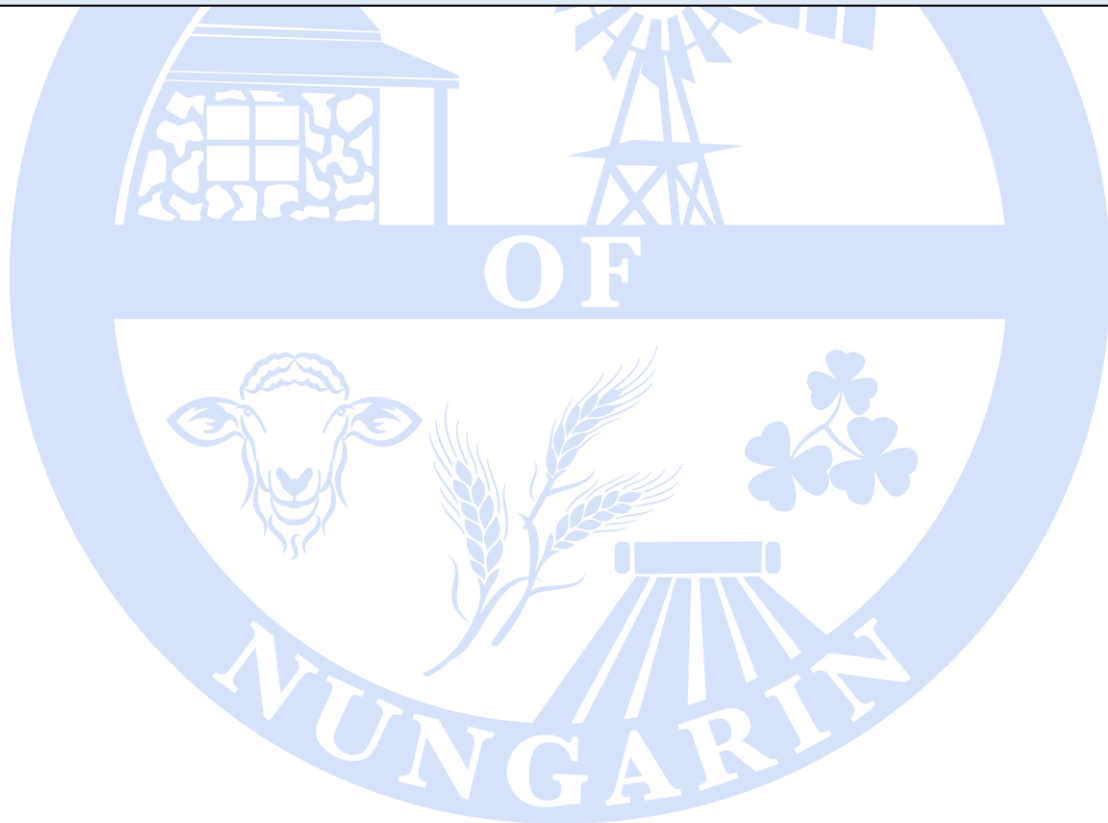

That Council approve, subject to the removal of the phrase ‘on the provision that no submissions were received during the public notice period’ from point three:

- The negotiated price of \$400,000 for the acquisition of land and buildings at Lot 300, 19 Second Avenue, Nungarin from CEACA, subject to finance;
- the Acting Chief Executive Officer to give one month’s Public Notice of Council’s intention to enter into a loan agreement with the Western Australian Treasury Corporation (WATC) for \$400,000.00 for an estimated period of 15 years, for the purpose of enabling Council to procure Lot 300, 19 Second Avenue Nungarin, containing 2x Central East Aged Care Alliance (CEACA) units;
- the Chief Executive Officer to apply for and establish the loan with WATC no earlier than one month after advertising the proposal;
- the amendment of the 2025/26 Budget to include the loan.

IN BRIEF

Council is required to consider authorising the public notice requirements for the intent to borrow funds to acquire the land and buildings at Lot 300, 19 Second Avenue Nungarin, as the proposed loan was not included in the 2025-2026 Adopted Budget.

Council is required to consider and approve the proposal to obtain a loan of \$400,000.00 from (WATC) to fund the acquisition of the CEACA Units located on lot 300, 19 Second Avenue Nungarin.

BACKGROUND

In 2012, eleven local governments formed an alliance known as the Central East Aged Care Alliance (CEACA), to address the issues affecting aged care in the Central Wheatbelt Region. CEACA was successful in obtaining funds through both Federal and State grants to construct a number of independent living units spread across the member shires.

The Shire of Nungarin was earmarked to receive six (6) independent living units but only two (2) independent living units were constructed. As part of its contribution to the construction of the units, the Shire gifted Lot 300, 19 Second Avenue, to CEACA.

On 27 October 2021 Council resolved to terminate its membership with CEACA and requested CEACA to transfer the balance of the vacant land at Lot 300 back to the Shire of Nungarin.

CEACA has contacted Council seeking if there was interest in acquiring the two independent living units and land at 19 Second Avenue, Nungarin.

REPORT DETAIL

During Ordinary Council meeting held 17th December 2025, Council delegated authority to the Chief Executive Officer to negotiate a sale price with CEACA on behalf of Council with the view of securing the best price possible for the acquisition of the two CEACA units.

During negotiations with CEACA, a loan amount of \$400,000.00 was agreed in principle. Council approval is now sought to enter into a loan agreement with WATC:

- after the expiration of 30 days, being the time required for public notice.

STATUTORY ENVIRONMENT

Local Government Act 1995

Section 6.20 Power to Borrow

- (1) Subject to this Act, a local government may —
- (a) borrow or re-borrow money; or
 - (b) obtain credit; or
 - (c) arrange for financial accommodation to be extended to the local government in ways additional to or other than borrowing money or obtaining credit,

to enable the local government to perform the functions and exercise the powers conferred on it under this Act or any other written law.

- (2) Where, in any financial year, a local government proposes to exercise a power under subsection (1) (**power to borrow**) and details of that proposal have not been included in the annual budget for that financial year —

- (a) unless the proposal is of a prescribed kind, the local government must give one month's local public notice of the proposal; and
- (b) the resolution to exercise that power is to be by absolute majority.

- (3) Where a local government has exercised a power to borrow and —

- (a) it does not wish to proceed with the performance of the function or the exercise of the power for which the power to borrow was exercised; or
- (b) after having completed the performance of the function or the exercise of the power for which the power to borrow was exercised, any part of the money borrowed, credit obtained or financial accommodation arranged has not been expended or utilized, the local government may resolve* to expend the money or utilize the credit or financial accommodation for another purpose if one month's local public notice is given of the proposed change of purpose.

* *Absolute majority required.*

- (4) A local government is not required to give local public notice under subsection (3) —
- (a) where the change of purpose has been disclosed in the annual budget of the local government for the relevant financial year; or
 - (b) in such other circumstances as are prescribed.

- (5) A change of purpose referred to in subsection (3) is to be disclosed in the annual financial report for the year in which the change occurs.
